Sealed Bids for the construction of the **BELTON DRIVE SEWER IMPROVEMENTS, CGRE170008** will be received by **Town of Williamston**, at the office of the **Town of Williamston, 12 W Main St, Williamston, SC 29697**, until **2:00 PM** local time on **Tuesday, November 19, 2019**, at which time the Bids received will be **publicly** opened and read. **The Project consists of installation of 3,150 LF of 8-inch gravity sewer including 820 LF of pipe bursting and 24 VF of manhole lining.**

Bids will be received for a single prime Contract. Bids shall be on a unit price basis.

Electronic copies of the Bidding Documents may be obtained in the same manner upon payment of a deposit of **\$50.00** for each set. Upon emailed request and receipt of the document payment indicated above, or electronic proof of check as submitted via email, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A non-mandatory pre-bid conference will be held at **8:30 AM** local time on **Tuesday, November 5, 2019** at the office of the **Town of Williamston, 12 W Main St, Williamston, SC 29697**. Attendance at the pre-bid conference is highly encouraged but is not mandatory. Bid security shall be furnished in accordance with the Instructions to Bidders.

**This project is being funded in whole or in part by the Community Development Block Grant Program (CDBG). All federal CDBG requirements will apply to the contract. All contractors are required to be registered in the federal System for Award Management (SAM). Bidders on this work will be required to comply with the President's Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, the Contract Work Hours and Safety Standards Act, and 40 CFR 33.240.**

**Bidders must also make positive efforts to use small and minority-owned business and to offer employment, training and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract.**

**All bidders are advised that the application with cost estimate is available for review. The owner reserves the right to waive any irregularities, or to reject any or all bids. No bidder may withdraw his bid within 90 days after the actual date of the opening thereof.**
